MEETING NOTICE. Public notice as to the meeting was given on April 11, 2022.

TURN ON DATE. Mr. White asked Mr. Flynn for an update on the maintenance crew. Mr. Flynn said the crew had a lot more burning to do and the weather reports predict winds in the next few days. Mr. Corn asked Mr. Flynn how long he wanted to postpone the turn-on date. Mr. Flynn requested a few more days and the meeting opened to comments from other participants. Lance Peterson, Craig Froerer, and Rob Wagstaff all agreed that conditions are dry, and they are ready for water as soon as possible. They requested the delay for the turn-on be no more than a couple of days. A motion was made by Mr. Nielson to move the turn on date to Wednesday, April 13, Mr. Ausman seconded, and it passed unanimously.

<u>ALLOTMENT</u>. Mr. Corn requested an update on the allotment. Current storage and inflows were discussed. Mr. Ausman proposed the allotment be increased from 2.1 to 2.25 feet per acre since that is available in storage. A motion was made Mr. White, seconded by Mr. Corn, and unanimously carried increasing the allotment to 2.25 feet per acre.

<u>DATE OF NEXT MEETING</u>. Mr. Ausman asked if the Joint Committee needed to set a time to meet on Wednesday and everyone agreed to wait and only hold a meeting that day if necessary.

<u>ADJOURNMENT</u>. There being no further business to come before the Committee, the meeting was adjourned at 9:21 a.m.
